## Wedding Terms & Conditions

1. The Minimum numbers charged for this wedding package is 100 guests.
2. A €500 non refundable deposit is required to secure a provisional booking. A provisional booking can only be held for two weeks. If the booking is not secured within this time it may be released without prior notice. Deposits are **STRICTLY** non-refundable. Deposits can be paid by cash, bank draft or credit card.
3. Cancellations charges in addition to the forfeit of the deposit paid will be charged in full if received within four weeks of the date booked. Cancellations charges will include all items booked.
4. Should you be forced to postpone your wedding the original deposit paid may be transferred to a date booked within four weeks of the date booked. Cancellation charges will include all items booked.
5. All prices quoted are in Euros and are subject to an annual review
6. Final numbers submitted to the hotel 48 hours prior to your reception will be the minimum numbers charged. Increases in your numbers attending will be charged accordingly
7. All accounts must be settled by bank draft 48 hours prior to the reception. We will provide you with a pro-forma invoice to facilitate this. Any outstanding balances must be settled on the day of your wedding.

8. The hotel will not accept responsibility for any entertainment that has not been reserved directly with the hotel. However, it is essential that all entertainment arrangements have the approval of the hotel management prior to the date of you reception.

9. All entertainment must provide their own equipment and accept full responsibility for same.

10. The hotel will accept no responsibility for wedding cakes. The Bride and Groom are responsible for the delivery and collection of their wedding cake. The hotel will not store wedding cakes for more than 2 days after wedding.

11. The hotel reserves the right to cancel or refund deposits in circumstances when a booking is made through a third party or under false pretence. Prospective clients must always meet with a member of management by appointment prior to acceptance of the first deposit. Deposits must be paid in person to the hotel, otherwise the hotel reserves the right to cancel the booking.
